Key Definitions

Harmonizing Codes – The manual process through which a customer's product identification or WCO Harmonized System are coordinated with codes used in Mexico.

IMMEX – Mexico's IMMEX program is an instrument to temporarily import goods and services that will be manufactured, transformed or repaired, and then re-exported without payment of taxes, compensatory quotas, and other specific benefits.

Maquiladora – A manufacturing operation in Mexico, where factories import certain material and equipment on a duty-free and tariff-free basis for assembly, processing, or manufacturing and then export the assembled, processed and/or manufactured products, sometimes back to the raw materials' country of origin.

Pedimento – The most relevant customs form that importers or exporters use during the importation or exportation of goods. The pedimento can only be completed by the Mexican customs broker (Agente Aduanal) at the request of the importer or exporter.

Pedimento Requirements – The instructions for completing the pedimento typically requires specific information about the goods such as: description, quantity, classification, origin, value, weight, and size. Identities of the importer, exporter, customs broker, freight forwarder, as well as the places involved, such as, the port of entry, place of delivery, place of shipment, and the use of free trade agreements, among other information may be required.

Tax Certification – Mexican tax law requires that invoices conform to a government-mandated standard, and that companies provide copies of the invoice to the Mexican federal government for verification. Companies with AR/AP operations outside of Mexico should be aware that this process is conducted mostly in Spanish.

Virtual Export – Under IMMEX, the ability to pass goods onto the customer tax and duty-free provided that both customers are certified VAT exempt by the Mexican government.

Virtual Import – Under IMMEX, the ability to import goods tax and duty-free and stock for customers future orders.
