### ■ Overview Description of Change:

- As a part of Molex's continuous effort to support our customer's demands, a transfer strategy for the MX150 2X3, 2x4, 2x6, 2X8, 2X10 blade series will be relocated to Guadalajara, MX.
- Molex will transfer only demand from Chengdu, China to Guadalajara, Mexico site 2 (Sur). The tools and lines are already at the Guadalajara Sur plant.
- This change only affects customers in Americas. Customers in EMEA (Europe, Middle East, and Africa) and Asia are no affected. China manufacturing plant will continue to supplying them.
- Guad Sur plant will have all the demand for this series (AME).
- The part number affected: please see PN list attached.
- PPAP will be available upon request. Submissions will not occur without request.
- PCN will be implemented once all required qualification/validation has been completed, and all necessary approvals have been obtained.
