Overview

- This PCN will be applied to Chinese customers only. All below changes will impact Chinese customers only.
 - 1. Existing CP2.8 rcpt terminal are produced in Molex Lincoln Nebraska plant, in order to mitigate the tariff impact between US-China and meet the Chinese customers' expectation on "local supply chain", we plan to build capacity in China to supply Chinese Customers' demand. The tooling will be new-design tooling.
 - 2. We will qualify additional raw material supplier to ensure material supply continuity. The additional source supplier is already an existing metals supplier qualified by Molex on other copper alloys. The additional supplier source will only affect product produced in China. New material supplier will help Molex keep up with current and future demand in China Market.
 - 3. The above change will follow qualification process of Molex. No change on fit, form and function.
 - 4. The above change will be applied to Chinese customers only. With this change, Molex Lincoln plant produced parts will be delivered to all other regions except for Chinese customers.
