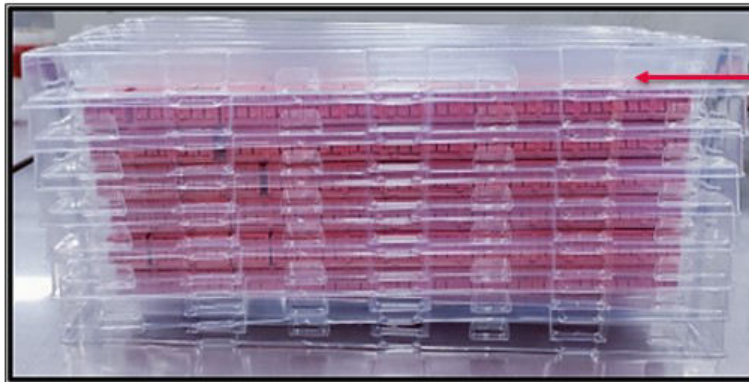
Before

Observation from Tray Utilization – Refer to Image

- Only 6 Filled tray and one empty tray at Top was left unutilized.

Issues Identified :

- Under utilization of tray space as shown in below image
- Tube capacity not optimized

After

- Tray packaging optimization - Evaluated the current packing method to ensure maximum utilization of tray packaging.
- **All 7 trays are filled and additional closure at top as shown in image below.**
- No change in packaging method, all packaging materials remains the same.
- DU needs to be change as provided in new quantity template provided along with this PCN to fill all the tray.
