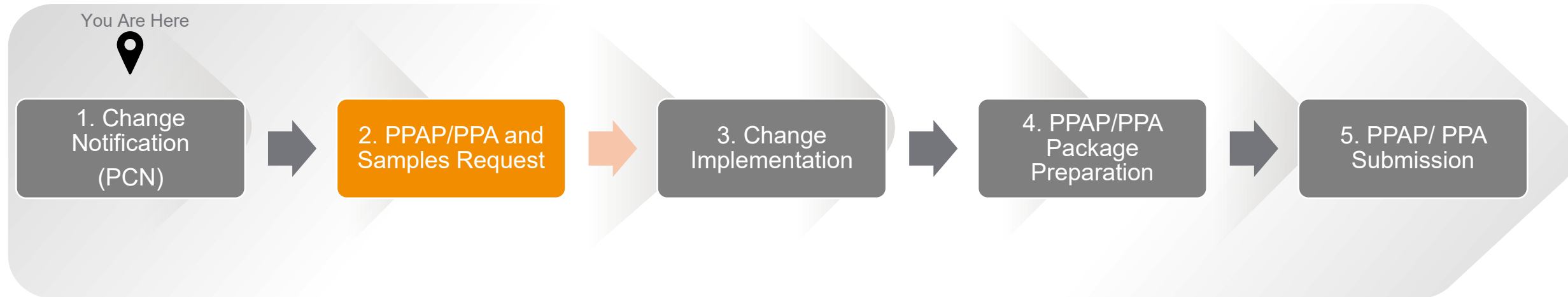

1. **Change Notification (PCN):** A formal communication from TE to the customer indicating an upcoming change.
2. **PPAP/PPA and Samples Request:** The customer must request PPAP/PPA and samples within two weeks of the notification date.  
Please confirm whether PPAP/PPA and samples are required at this stage.  
Contact your TE Sales representative within two weeks of receiving the Change Notification.

3. **Change Implementation:** TE conducts internal processes to execute the change.
4. **PPAP/PPA Package Preparation:** TE begins preparing the PPAP/PPA packages. The customer will receive an automated notification from the [www.te.com](http://www.te.com) ePPAP system.
5. **PPAP/PPA Submission:** The PPAP request is made available and submitted to the customer. Samples will be provided if applicable.  
Following submission, please provide approval within four weeks. If approval is not received within this timeframe, TE will proceed with the change to avoid delivery delays.

# Validation Scope - Details

The change follows a strict procedure, which fully maintains quality, ability to supply and form-fit-function of the concerned products, including internal release and product validation as per OEM/CAM requirements, where applicable.

The TE manufacturing locations operate under a certified quality management system in accordance with defined requirements.

In case of changes impacting product families, and PPAP is required, TE will provide a family PPAP.

This will be based on a representative part-number of the family and will approve all part-numbers impacted by the mentioned change.

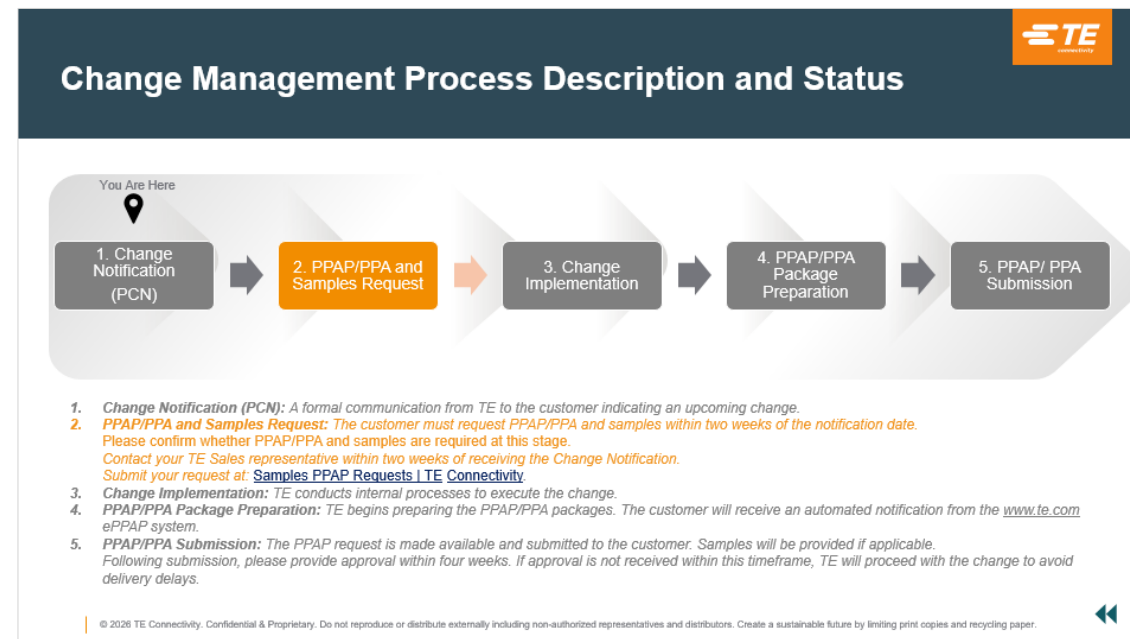
